

BLAKENEY SAILING CLUB
Annual Consent Form for Youth Members

Aged under 18 years old at the start of the Blakeney Sailing Club season
(To be signed by parent or guardian of the youth member and NOT their representative)

Parents and guardians are warned that the Club is only able to provide patrol facilities for those participating in Club racing and other Club organised sailing events.

Parents and guardians have sole responsibility for their children and wards and must appreciate that the Club cannot be expected to exercise supervision or control. Even during Club racing or other organised sailing event the Club cannot accept responsibility for children, or any other persons, engaged in racing or other organised sailing event.

The Race Officer (RO) / Event Organiser (EO) has the right to refuse entry in any event if he/she believes the conditions are not suitable for a youth member to take part. Youth members will follow the safety instructions issued by RO/EO or Patrol Boat (PB) helms

Risk Statement

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk.

By allowing my child to participate in Blakeney Sailing Club activities, I, the parent/guardian of the child mentioned above agree and acknowledge that:

- a) I am aware of the inherent element of risk involved in the sport and accept responsibility for exposing my child to such inherent risks
- b) I have satisfied myself that my child has the necessary skill and knowledge to take part in Blakeney Sailing Club activities and to deal with conditions that may arise in the course of a race or other BSC sailing activity (see below)
- c) I will not allow my child to participate in Blakeney Sailing Club activities whilst under the undue influence of alcohol, drugs or whilst otherwise unfit to participate
- d) I am responsible for ensuring that the boat is in good order, equipped and insured (including third party insurance of at least £2 million) to take part in Blakeney Sailing Club activities.
- e) I am responsible for my child's property whether afloat or ashore
- f) I accept responsibility for any injury, damage or loss to the extent caused by my own actions or omissions or actions or omissions of my child
- g) the provision of a race management team, patrol boats and other officials and volunteers does not relieve me of my parental/guardianship responsibilities or my child of his/her responsibilities
- h) the provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances
- i) My child is bound by the Blakeney Sailing Club Sailing Instructions and Racing Rules of Sailing (save as amended by the Sailing Instructions)
- j) I will inform the EO about any disability/medical condition that may affect my child during events, and any medication that they may require. This information may be shared with those responsible for supervising the event.

I confirm that my dependant has at least a minimum level of competence equivalent to RYA Youth Scheme Level 3, or equivalent to RYA National Scheme Level 2. The RYA Scheme covers Rigging, launching and recovery, sailing techniques, capsized recovery and sailing theory and the ability to launch and sail a dinghy around a triangle in moderate conditions. I grant to the Blakeney Sailing Club without payment the right in perpetuity to make, use and show any motion pictures, still pictures of or relating to the activities organised by BSC. Conditions of Use of photography or video

1. We will normally only identify a child by reference to the child's first name.
 2. We will not use personal details or full names (ie. first name and surname) of any child to accompany a photographic image on video, on our website, in our organisation brochure or any other electronic or printed publications without good reason. 'Good reason' includes using the full name of a child in a newsletter to organisation members if the child has won a trophy or award.
 3. We will not include personal email or postal addresses, telephone or mobile numbers on video, on our website, in our organisation brochure or in other electronic or printed publications without consent.
 4. We may use group photographs or video with very general labels.
 5. We will only use images of children who are suitably dressed, to reduce the risk of such images being used inappropriately.
 6. Photographs or video may be used for coaching purposes or by officials during competition to illustrate incidents on the water.
 7. Commercial sale of any form of media will be limited to the Blakeney Sailing Club.
