A corresponding tag will then be provided to you, to attach to the boat as a point of reference. **This is a one-off registration, you do not need to register again unless you lose the tag, however, please do ensure that you notify us of any change of contact details please.**

Therefore, please help us by completing the information below and returning this form to the Parish Office (01263 741106) (or the Carnser Car Park Attendants Hut between 1st April & 31st October only).

As you may know, it has always been free to all users, with the costs borne by Blakeney Parish Council. However, restrictions on local government finance mean that we need to widen our funding sources to maintain and run the Dinghy Park for all users in the longer term. To this end we are inviting all who enjoy using the Dinghy Park at Blakeney whether on a short holiday or for the season,
